A large number of companies (almost all public interest entities) are now required to comply with Indian Accounting Standards (Ind AS). Many companies are voluntarily adopting Ind AS. With the implementation of Ind AS the requirement of various disclosures has increased significantly. Notes to accounts and disclosures are extremely important to decipher the financial numbers.

Many of the notes and disclosures are either required by the Companies Act, 2013 or by the Ind AS while some are industry specific requirements. Further, companies are voluntarily making additional disclosures to enable stakeholders to understand the financial statements better and make them comparable with other companies.
